Text of Amendment.

The title of the Articles of Incorporation of the Corporation is hereby amended to read "ARTICLES OF INCORPORATION OF ROCA TILES USA INC."; and Article I of the Articles of Incorporation is hereby be amended to read as follows:

"ARTICLE I

The name of this corporation (the "Corporation") is Roca Tiles USA Inc."

Date of Adoption of Amendment.

Procedure and Sufficiency of Shareholder Votes.

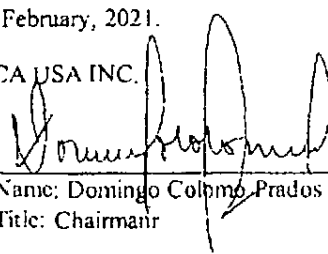
