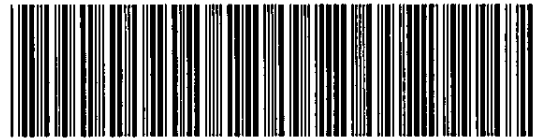



ARTICLES OF INCORPORATION
OF
FURTHER FASTER INITIATIVES, INC.

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation of such Corporation.

ARTICLE I

The name of the Corporation shall be:

FURTHER FASTER INITIATIVES, INC.

The address of the principal office of this Corporation shall be 1841 Country Club Drive, Tallahassee, Florida 32301 and the mailing address of the Corporation shall be the same.

ARTICLE II

The period of duration of the corporation shall be perpetual.



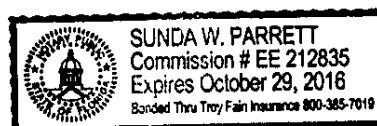


