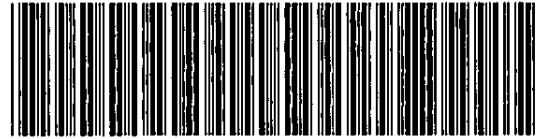

ARTICLE ONE


