The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, does hereby form a for profit corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the Corporation shall be: ALLEN KIESEL AND ASSOCIATES, P.A.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal place of business and mailing address is: 1919 Malmsey Court, Titusville, Florida 32796.

ARTICLE III - PURPOSE

The specific purpose of this corporation is as follows:

- a. to render professional architectural services and engage in any of its fields of specialization;
- b. to invest its funds in real estate, mortgages, stocks, bonds, or any other type of investments;
- c. to own real or personal property necessary for the rendering of professional services;
- d. to engage in no other business other than the rendition of the professional services specified herein; and
- e. to do everything necessary and proper in accomplishing said purposes herein, and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.
