
I HAVE NO INTENTIONS OF REVOKING THE DISSOLUTION OF LUMINOSITY SOLUTIONS INC P03000132568, and the corporation name is free to be used again.

I am requesting that you allow my new corporation to have the same name as my old corporation. I have dissolved the existing Luminosity Solution Inc, and I have filed for a new FL corp with the same name.

The reason why I closed one corp and why I am restarting another with the same name:

1. I did a name change to an existing FL Corp that I started back in 2003.
2. I called the IRS in September and they informed me I could change the name of my existing corp and use the same EIN, and just turn that name change in with my end of year taxes.
3. This is causing a problem with opening bank accounts and setting up payroll tax services to automatically pay my taxes. Since the company name and EIN do not match.
4. I called the IRS Monday to resolve the new company name to the existing EIN:
 - a. The only way to do a change of name besides mailing it in with your taxes is to mail a letter to the Entity Office of the IRS, this process will take greater than 60 days due to the back log of the federal shutdown.
5. The IRS suggested since I was just starting a new business, why not just start a new corp, instead of the name change that I did in September.
6. I could then immediately file Form 2553 and retain my S-Corp election, same as with my previous corp.
