

ARTICLES OF INCORPORATION OF CRISTINA LAMPURI, M.D., P.A.

ARTICLE I NAME, PRINCIPAL PLACE OF BUSINESS, AND DURATION

The name of the Corporation is CRISTINA LAMPURI, M.D., P.A. The principal place of business of the Corporation is 120-A Butler Street, West Palm Beach, FL 33407. The duration of the Corporation is perpetual.

ARTICLE II REGISTERED OFFICE AND AGENT

The address of the registered office in the State of Florida is 120-A Butler Street, West Palm Beach, FL 33407. The name of the registered agent at such address is CRISTINA LAMPURI.

ARTICLE III CORPORATE PURPOSES, POWERS, AND RIGHTS

- 1. The nature of the business to be conducted or promoted is to engage in the practice of medicine and healthcare services. The purpose of the Corporation is any lawful act or activity for which a professional service corporation engaged in such profession may be organized under the Professional Service Corporation and Limited Liability Company Act, and for which such a corporation is permitted to engage in under other applicable law.

The merger or consolidation of the Corporation into or with any other corporation, the merger of any other corpora-tion into it, or any purchase or redemption of shares of stock of the Corporation of any class shall not be deemed to be a dissolution, liquidation, or winding up of the Corporation for the purposes of this paragraph.

- Any person, upon becoming the owner or holder of any shares of the Common (e) Stock or other securities having voting rights issued by this Corporation ("shareholder"), does thereby consent and agree that all rights, powers, privileges, obligations, or restrictions pertaining to such person or such securities in any way may be altered, amended, restricted, enlarged, or repealed by legislative enactments of the State of Florida or of the United States hereafter adopted which have reference to or affect corporations, such securities, or such persons if any; and that the Corporation reserves the right to transact any business of the Corporation, to alter, amend, or repeal these Articles of Incorporation, or to do any other acts or things as authorized, permitted, or allowed by such legislative enactments.
