ARTICLES OF INCORPORATION OF AKL PROPERTY, CORP.

Pursuant to the provisions of Chapter 607 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned incorporator, for the purposes of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is AKL PROPERTY, CORP. (the "Corporation").

ARTICLE 2 DURATION, PLACE OF BUSINESS AND MAILING ADDRESS

Any repeal or modification of the foregoing provisions of this Article 8 shall not edversely affect any right or protection of a director or agent of the Corporation existing at the time of such repeal or modification.
