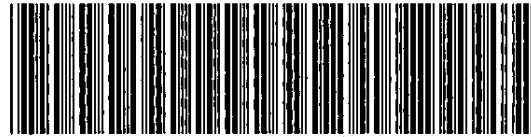

ARTICLES OF INCORPORATION
OF

Article I – Name

The name of this corporation is:

EMERY AUTO & DIESEL REPAIR, INC.

Article II – Duration

This corporation shall have perpetual existence.

Article III – Purpose

The power to adopt, alter, amend or repeal By-laws shall be vested in the Board of Directors, and the Shareholders.


Article X - Indemnification



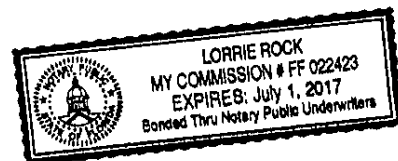


