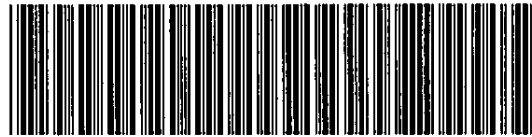

Article I - Corporate Name



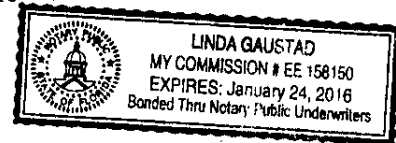
