The undersigned Incorporator, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation is **BROWARD INTERNATIONAL UNIVERSITY INC.**

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS**

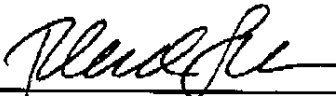
**ARTICLE IX. BYLAWS**
