

ARTICLES OF INCORPORATION OF LAW OFFICE OF FRANK P. SAIER, P.A.

The undersigned, subscriber to these Articles of Incorporation, being a natural person competent to contract and an attorney licensed to render professional legal services as such, hereby associate myself in the formation of a professional corporation under the laws of the State of Florida, pursuant to the provisions of Chapter 621, Florida Statutes.

ARTICLE I CORPORATE NAME

The name of the corporation shall be LAW OFFICE OF FRANK P. SAIER, P.A. The company shall have perpetual existence.

ARTICLE II

GENERAL PURPOSE

The general purpose for which this corporation is organized shall be:

To engage in every phase and aspect of the business of rendering professional legal services to the public as allowed under the Laws of the State of Florida, but such professional services shall be rendered only through the corporation's officers, employees and agents who are licensed or otherwise legally authorized under the laws of the State of Florida to conduct a legal practice.

ARTICLE III

If, from time to time, a shareholders' agreement among all of the shareholders of the Corporation is in effect regarding the Subchapter S status of the Corporation pursuant to the Internal Revenue Code of the United States in effect from time to time, then transfers of the Corporation's Common Stock made not in accordance with such agreement, whether by operation of law or otherwise, are null and void <u>ab initio</u>.


