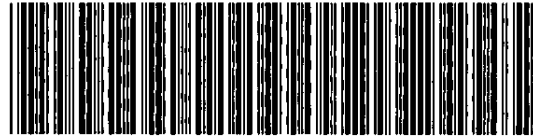



In compliance with the requirements of Chapters 607 and 621, Florida Statutes, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a Professional Service Corporation.

ARTICLE I

The name of the Corporation is: **CONCILIO LAW, P.A.**

ARTICLE II

The existence of the Corporation shall begin on the date these articles are filed with the Secretary of State of the State of Florida.
