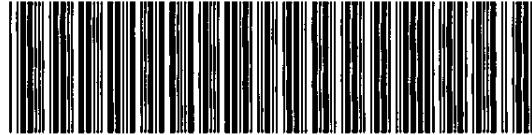

Good Morning,

We apologize for the delay in our reply.

Is the tax id number she provided (46-4237789) your Social Security Number? Please reply back if it is and we'll have it removed immediately. This office does not request Social Security Numbers on any filings nor would we knowingly accept the number.

The Division of Corporations of the Dept. of State acts as a ministerial filing office only. We have no authority to investigate individual claims against corporations nor can we regulate the affairs of private corporations. Documents filed with our office are accepted at face value and filed if they meet statutory filing requirements. If false information is contained in the document, it is up to the party "harmed" to correct the error or bring action against the business entity or individual through the courts. Section 817.155 Florida Statutes, which states that it is a **third-degree** felony to sign a document he or she knows is false in any material respect.

If you point out the seriousness of this matter hopefully they will resolve it quickly.

If she does not voluntarily remove your name I'd recommend you file a police report. In addition I would recommend contacting your bank to get assistance on placing a Fraud Alert with the three credit bureaus.
