
ARTICLE X


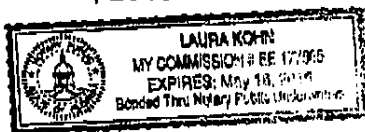
