ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF JENNIFER JOHNSON, P.A.

- 1. The Name of the corporation is: Jennifer Johnson, P.A. (the "Company").
- 2. The date of filing of the Articles of Incorporation of the Company was December 9, 2013 and assigned document number P13000098046.
- 3. The Company amends its Articles of Incorporation by amending Article I. Article I is deleted in its entirety and the following is substituted therefore:

"ARTICLE I NAME

The name of this corporation is Jennifer Johnson, M.D., P.A. The duration of the corporation is perpetual. The effective date upon which this corporation shall come into existence shall be the date these Articles are filed by the Secretary of State. The general purpose for which this professional association is organized shall be (i) to render healthcare services to the general public, and to do all things in connection therewith that are customarily done by medical doctors under the laws of the State of Florida and (ii) in furtherance of its corporate purposes, the professional association shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Professional Service Corporation Act."

Except as amended hereby, the Articles of Incorporation shall remain in full force and effect.

These Articles of Amendment to the Articles of Incorporation were approved by the sole Shareholder of the Company on February 24, 2016. The number of votes cast in favor of this Amendment was sufficient for approval.
