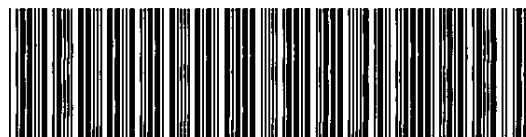


1. The name of the Converting Corporation at its incorporation and immediately prior to the filing of this Certificate of Conversion was "BWE CONVERSION, INC."

10. The Converted Entity has agreed to pay any shareholders having appraisal rights the amount to which they are entitled under §§ 607.1301-607.1333, Florida Statutes.
