

ARTICLES OF INCORPORATION

OF

ARTICLE I. NAME

The name of this corporation is JAN' OF ALL TRADES ETC., INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2014, and shall have perpetual existence.


