ARTICLES OF INCORPORATION
OF
WANG'S SUNSHINE RECYCLING INC.

Pursuant to Chapter 607 of the Florida Statute (the "Florida Business Corporation Act"), the undersigned, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME AND PRINCIPAL OFFICE

The name of the corporation shall be WANG'S SUNSHINE RECYCLING INC. (hereinafter the "Corporation"), and the principal office shall be at 5805 N 50th St., Suite 50, Tampa, FL 33610.

ARTICLE II DURATION

The period of duration of the Corporation shall be perpetual.

ARTICLE III PURPOSES
