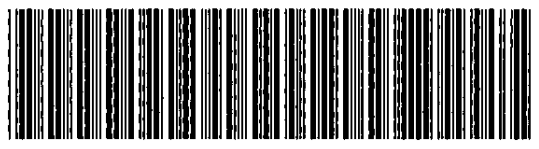

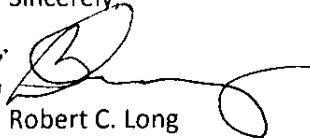

**Pursuant to Chapter 607 and/or 621 F.S.,**

Article 1.

The name of the corporation is **BOB LONG ASSOCIATES, INC.**
