The name of this corporation shall be INTERNATIONAL DÉCOR OF FLORIDA, INC.

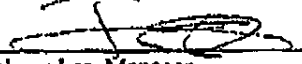

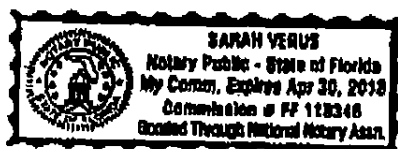

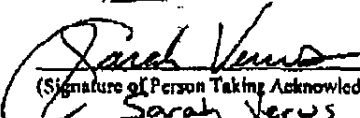
