The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation:

Article One

NAME

The name of the corporation is NEWS MEDIA CONSULTING, INC.

Article Two

DURATION

The term of existence of the corporation is perpetual.

Article Three

PURPOSE

The corporation will assist clients in achieving the maximum benefit from all interactions with the news media, and may engage in any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

Article Four

CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is seven hundred and fifty (750), which shall be common shares with a par value of ten dollars (\$10.00).
