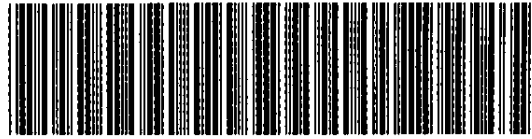

**ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I: NAME**

The name of the corporation shall be:

The principal place of business of this corporation shall be:

The Board of Directors may from time to time move the principal office to any other address in Florida.

**ARTICLE II: NATURE OF BUSINESS**

This corporation is organized for the purpose of providing real estate sales services and transacting any or all other lawful business permitted under the laws of the Florida Real Estate Commission, the State of Florida or any other state and of the United States.

**ARTICLE III: SHARES**

**ARTICLE V: TERM OF EXISTENCE**

This corporation is to exist perpetually, commencing on January 1, 2014.

**ARTICLE VI: PRE-EMPTIVE RIGHTS**

Every shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof at the price for which it is offered to others.
