## ARTICLES OF INCORPORATION OF BUILDERS INSULATION HOLDINGS, INC.

The undersigned, acting as the incorporator of a corporation under Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

The Corporation is incorporated under Chapter 607, Florida Statutes.

#### ARTICLE II


#### ARTICLE V
