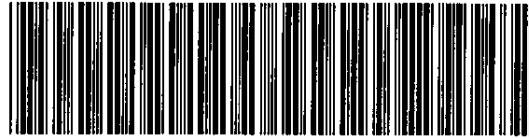


I was not aware that the effective date could be the year following the year of the filing date.
