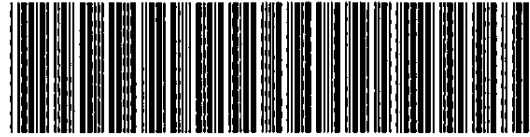

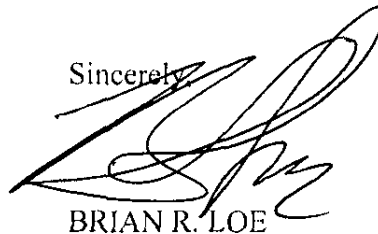

ARTICLES OF INCORPORATION
OF
PHARAOHS TREASURE, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is PHARAOHS TREASURE, INC.

ARTICLE II

The existence of the Corporation shall begin upon filing with and acceptance of these Articles by the Secretary of State of Florida and shall be perpetual thereafter. The purpose for which the corporation is organized is wholesale jewelry sales, distribution and marketing of imported goods and, any and all other lawful and permissible business purposes.

ARTICLE III

The street address of the principal office of the Corporation is 2723 Timberlake Avenue, Deltona FL 32725.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100 of a par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. Transfer of any share of this class of stock is subject to a right of first refusal of the other shareholders. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

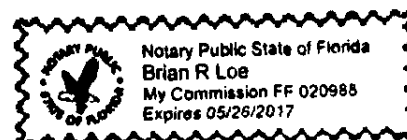

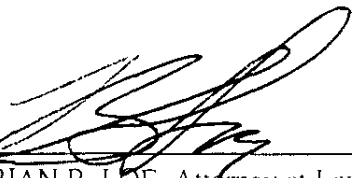
