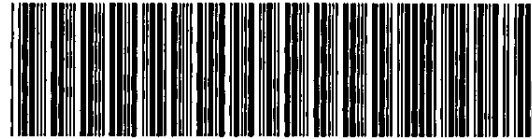

The undersigned initial subscribers to these Articles of Incorporation, natural persons competent to contract, hereby forming a Corporation under the laws of the State of Florida, adopts the following ARTICLES OF INCORPORATION for the corporation.

ARTICLE I - NAME

The name of the Corporation is: Do It Yourself Pest & Lawn Products, Inc.

ARTICLE-PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 1180 West State Road 436, Altamonte Springs, Florida 32714.

ARTICLE III - PURPOSE

The general character or nature of the business to be transacted by this Corporation is as follows:

- a) To acquire by purchase, lease or otherwise, lands and interest in lands, and to own, hold, improve, develop and manage any real estate so acquired, and to erect or cause to be erected, on any lands owned, held or occupied, and to encumber or dispose of any lands, or interest in lands, and any buildings or other structures, at any time owned or held by the Corporation. To buy, sell, mortgage, exchange, lease, hold for investment or otherwise, use and operate, real estate of all kinds improve or unimproved, or any right or interest therein.
- b) To acquire by purchase, lease, manufacture or otherwise, any personal property deemed necessary or useful in the equipment, furnishing, improvement, development or management of any property, real or personal, at any time owed, held or occupied by the Corporation, and to invest, trade, lease, rent, encumber or dispose of any personal property at any time owned or held by the Corporation.
- c) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and to execute such mortgages, transfers of Corporate property, or other instruments to secure the payment of Corporate indebtedness as required.
- d) To purchase the business assets of any business entity and engage in the same or other character of business.
- e) To become a partner with any person or persons, corporation, or any other business entity and engage in the same or other character of business.
- f) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of capital stock of, or any bonds, securities, or other evidences of indebtedness created by a corporation or the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
- g) To enter into, make, perform and carry out contracts and agreements of every kind, for any lawful purpose, without limit as to amount, with any firm, association or corporation, or calculated to facilitate the same.

- h) To carry on any or all of its operations and business, and to promote its objects within the State of Florida or elsewhere, without restriction as to the place or amount, and to have, use, exercise and enjoy all of the general powers of like Corporations.
- i) To do any or all of the things herein set forth to the same extent as natural persons might or could do, and in any part of the world as principals, agents, contractors or otherwise, alone or in company with others, and to do and perform all such things and acts as may be necessary, profitable or expedient in carrying on any of the business or acts above named.

The intention is that none of the objects and powers as hereinabove set forth, except where otherwise specified in this Article, shall be in any way limited or restricted by reference to or inference from the terms of any other objects, powers, or clauses of this Article or any other Articles, but that the objects and powers specified in each of the clauses in this Article shall be regarded as independent objects and powers.

ARTICLE IV-SHARES

The aggregate number of shares of stock which the corporation shall have authority to issue is: one hundred (100) shares which shall be common stock having a par value of \$1.00. Each share shall have one vote on all business affairs of the corporation, at any business meeting.

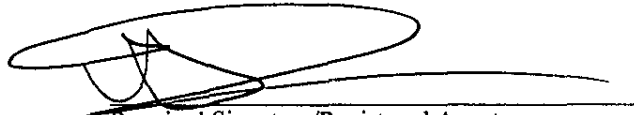

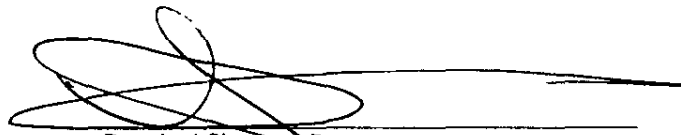
