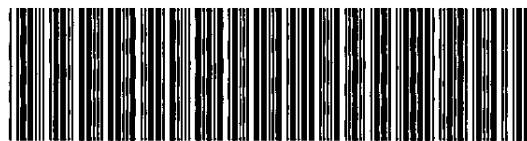

ARTICLES OF INCORPORATION

OF

RJM Advisors, Inc.

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is **RJM Advisors, Inc.**


