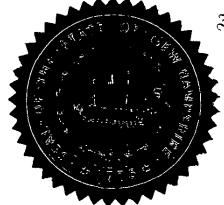

## IN THE MATTER OF Application for Approval of Redomestication of Foreign Insurer B ALLIED WORLD REINSURANCE COMPANY

#### FINDINGS AND FINAL ORDER

The New Hampshire Insurance Commissioner Roger A. Sevigny (the "Commissioner") pursuant to RSA 405:62 and 405:64, has carefully considered the application of Allied World Reinsurance Company (Allied World Re) filed on August 11, 2009, as supplemented from time to time (the "Application"). The Application seeks approval for the redomestication of Allied World Re from New Jersey, its current state of domicile to New Hampshire.

The Examination Division of the New Hampshire Insurance Department (the "Department") has completed a thorough review of the Application and has reviewed additional documentary information provided by the Applicant at the Department's request. Based upon the Application and the accompanying documents, the following findings of fact and conclusions of law have been reached:

#### FINDINGS OF FACT AND CONCLUSIONS OF LAW

- Allied World Re is a New Jersey corporation. All of the outstanding stock of Allied World Re is owned by Allied World Assurance Holdings (U.S.), a Delaware holding company with its statutory home office at 830 Bear Tavern Road, West Trenton, NJ 08628 and its administrative office at 225 Franklin Street, Boston, MA 02110.
- 2. Allied World Re has proposed that it be redomesticated as a New Hampshire domestic insurance company by amending and restating its Articles of Incorporation to designate New Hampshire as its state of corporate domicile, effective as of November 1, 2009.
- 3. Based upon all of the material filed in this matter, the Commissioner finds that Allied World Re has complied with all requirements of New Hampshire law relative to the organization and licensing of a domestic insurer and has designated its principal place of business (statutory home office) in New Hampshire, and accordingly is qualified for redomestication as a New Hampshire domestic insurance company, pursuant to RSA 405:62 and 405:64.
- 4. Having considered the prototype policy forms in use by Allied World Re and in light of the fact that only the home office address will change, no forms filing will be necessitated by the redomestication.

NOW THEREFORE, it is hereby ORDERED by the New Hampshire Insurance Commissioner that:

- A. The Application by Allied World Re for redomestication to New Hampshire, pursuant to and in accordance with RSA 405:62, is hereby **APPROVED**, with the redomestication to be effective as of November 1, 2009.
- B. The proposed Restated Articles of Incorporation Including Designated Amendments of Allied World Re which were submitted as part of these proceedings are hereby approved. Upon endorsement by the Commissioner, the duly certified Restated Articles of Incorporation shall be filed with the New Hampshire Secretary of State as provided in RSA 401:8 and pursuant to RSA 405:65.
- C. Pursuant to RSA 405:64, the redomestication of Allied World Re shall have the following effects:
- i. The Certificates of Authority, licenses, producers' appointments, rates and all other incidents of authority to engage in the business of insurance of Allied World Re that are in existence as of the date hereof, shall continue in full force and effect so long as Allied World Re remains duly qualified to transact the business of insurance in New Hampshire.
- ii. The outstanding policies of Allied World Re shall remain in full force and effect and need not be endorsed as to its new state of domicile or new location; and
- iii. Allied World Re may continue to use existing policy forms until such time as Applicant has filed new policy forms with, and has had such forms approved by, the New Hampshire Insurance Department.
