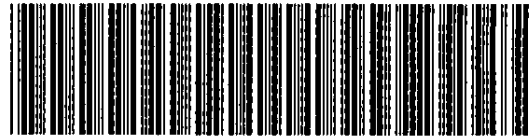

In compliance with Chapter 607, F.S., Florida Profit

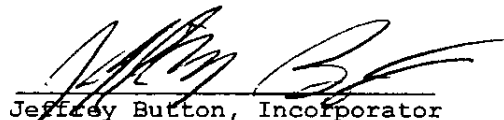
ARTICLE EIGHT
