ARTICLES OF INCORPORATION
OF
EVERGREEN FUNERAL HOME, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I.

The name of the corporation is Evergreen Funeral Home, Inc.

ARTICLE II.

The duration of the corporation is perpetual, and the time of commencement of its corporate existence shall be January 1, 2014.

ARTICLE III.

The general purposes for which this corporation is formed are to do any or all things herein set forth to the same extent as natural persons might or could do and in any part of the world, as principals, agents, contractors, trustees, or otherwise, within or without the State of Florida, either alone or in concert with others, and to carry on any other business in connection therewith, whether manufacturing or otherwise, and to do all things not forbidden by the laws of the State of Florida.

The specific and primary purpose for which this corporation is formed is to operate a funeral home for the benefit of the customers of Evergreen Cemetery Association.

ARTICLE IV.

The aggregate number of shares which the corporation is authorized to issue is 10,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$0.10 per share.

ARTICLE V.

The street address of the initial registered office of the corporation is 1515 Riverside Avenue, Suite A, Jacksonville, Florida 32204, and the name of its initial registered agent at such address is Frazier & Frazier, Attorneys at Law, P.A.

ARTICLE VI.

The method of election of directors shall be stated in the bylaws of the corporation.
