ARTICLES OF INCORPORATION
OF

ARTICLE I - Name

The name of the corporation is OKAN INTERNATIONAL LANGUAGE CENTER, INC. (the "Corporation").

The Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent permitted by law in existence either now or hereafter.


ARTICLE IX - Fiscal Year
