The undersigned incorporator, for the purpose of forming a limited liability company under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be: CHANDRAWATI MARAJ, P.A.

The general purpose of the business to be transacted by this Corporation is:

The foregoing paragraphs shall be construed as enumerating both objects and purposes of this corporation and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.
