The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is D&G Food Group, Inc., and its principal office and mailing address is 1227 N. Franklin Street, Tampa, Florida 33602.

ARTICLE II

Commencement and Term of Corporate Existence

The corporation shall come into existence on the date of filing with the Florida Secretary of State. This Corporation shall have perpetual existence.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV

Capital Stock

By-Laws

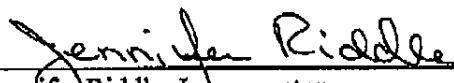
