**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, STUDER HOLDINGS, INC., a Delaware corporation competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is STUDER INTERNATIONAL, INC.

This corporation is referred to in these Articles of Incorporation as the "Corporation."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSE AND POWERS

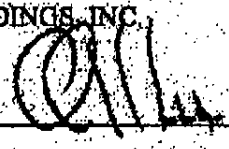
