Pursuant to Section 607:1006, Florida Statutes, the Amended Articles of Incorporation of FloridaLeakPros.com Inc., a Florida profit corporation (the "corporation"), effectively formed on January 1, 2014, and assigned document number P14000002017, are hereby further amended as follows:

Article IV is hereby stricken in its entirety and replaced with the following:

ARTICLE IV

This corporation is authorized to issue a total of 2,000 shares of common stock. Of those 2,000 shares, this corporation is authorized to issue up to 1,000 shares of Class A Voting common stock and up to 1,000 shares of Class B Non-Voting common stock. The rights, privileges, and preferences of the Class A Voting common stock and the Class B Non-Voting common stock shall be identical, except that all voting rights of common stock shall be vested in the shares of Class A Voting common stock, entitling each share of issued and outstanding Class A Voting common stock to one vote upon any matter upon which the shareholders are entitled to vote.
