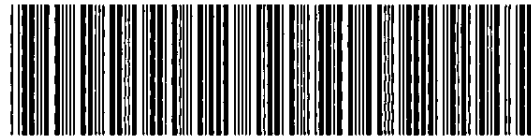

ARTICLES OF INCORPORATION
OF
EMANUEL MARATHON, INC.

ARTICLE I – NAME

The name of this Corporation is: EMANUEL MARATHON, INC.

ARTICLE II – PURPOSE

This corporation is formed for the purposes of operating and transacting any and all lawful business.

ARTICLE III – CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock, which shall be designated "Common Shares".

Authorized capital stock may be paid for in cash, services, or property, at a just value to be fixed by the Board of Directors of this corporation in any regular or special meeting.

ARTICLE IV – PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V – INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VIII – BYLAWS

ARTICLE XII – APPROVAL OF SHAREHOLDERS REQUIRED FOR MERGER

The approval of the Shareholders of this Corporation to any plan of merger shall be required in every case, whether or not such approval is required by law.


ARTICLE XIII – AMENDMENT

ARTICLE XIV – MISCELLANEOUS PROVISIONS



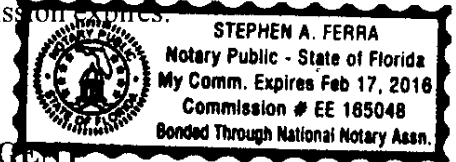


