OF

FBSURGERY, INC.

The undersigned incorporator, for the purpose of forming a corporation in the state of Florida hereby adopts the following Articles of Incorporation.

Article I

Name and Duration

The name of this corporation is FBSurgery, Inc. The duration of the corporation is perpetual. The effective date upon which this corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

Article II

Principal Office

The address of the principal office and mailing address of the corporation in the State of Florida is 1340 S. 18th Street, #140, Fernandina Beach, Florida 32034.

Article III

Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares having no par value.

Article IV

Registered Office and Agent

The street address of the registered office of this corporation is 1340 S. 18th Street, #140, Fernandina Beach, Florida 32034 and the name of the registered agent of this corporation at that address is Samuel E. Perkins, M.D.

Article V

Directors

1. This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one (1). The manner of selection of directors shall be as provided in the bylaws.






