The undersigned incorporator, for the purpose of forming a corporation in the state of Florida hereby adopts the following Articles of Incorporation.

## Article I Name and Duration

The name of this corporation is FBSurgery, Inc. The duration of the corporation is perpetual. The effective date upon which this corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

## Article II Principal Office

The address of the principal office and mailing address of the corporation in the State of Florida is 1340 S. 18<sup>th</sup> Street, #140, Fernandina Beach, Florida 32034.
