# ARTICLES OF INCORPORATION OF GULF STATES TRUCK & TRAILER REPAIR CORP.

Pursuant to Florida Statutes Section 607.0201 and Chapter 621, the undersigned hereby submits the following Articles of Incorporation of GULF STATES TRUCK & TRAILER REPAIR CORP., a corporation being organized under the laws of the State of Florida.

#### **ARTICLE 1. - NAME**

The name of the corporation is GULF STATES TRUCK & TRAILER REPAIR CORP. (hereinafter called the "Corporation").

#### **ARTICLE 2. – PURPOSE**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

#### **ARTICLE 3. -CAPITAL STOCK**

The Corporation shall have authority to issue a total of two hundred (200) shares common stock, consisting of:

- (1) One hundred (100) shares of Class A Voting Common Stock, without par value; and
- (2) One hundred (100) shares of Class B Nonvoting Common Stock, without par value.

Shareholders of the Class B Nonvoting Common Stock shall not have the right to vote, but shall have all the other rights and preferences as the Shareholders of the Class A Voting Common Stock.
