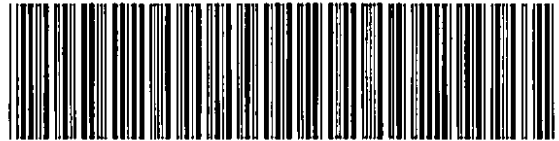



## **AGREEMENT FOR PURCHASE AND SALE OF BUSINESS**

This Agreement made this 27 day of June, 2018 by and between Steve Ellis Hill (hereinafter referred to as "Seller") and Michael David Mitch & Cheanay Nichole Pritchett (hereinafter collectively referred to as the "Buyer").

Whereas the Seller desires to sell and the Buyer desires to buy Your Pool Boys, Inc., d/b/a Ocala Pool Boys, now being operated at 1619A North Magnolia Avenue, Ocala, Florida 34475, a swimming pool supply store and all assets thereof. The parties hereto agree and covenant as follows:

1. The total purchase price for all fixtures, furnishings and equipment is EIGHTEEN THOUSAND and 00/100 DOLLARS (\$18,000.00) payable as follows:

a) THREE THOUSAND and 00/100 DOLLARS (\$3,000.00) the receipt of which is hereby acknowledged by Seller.

b) Inventory with a current fair market value of \$10,000.00, the sufficiency and receipt of which is hereby acknowledge by Seller.

c) The remaining balance of \$5,000.00 shall be paid in monthly installments of EIGHT HUNDRED and 00/100 DOLLARS (\$800.00) beginning on the twenty-second day of June, 2018 and continuing on the twenty-second day of each month thereafter for a period of six (6) months, followed by a final payment of \$200.00 on or before December 22, 2018.


Seller agrees that the Buyer will not pay interest on the outstanding principal owed on this Agreement. Buyer agrees to sign a Note securing payment of the outstanding balance at the request of the Seller.

2. The Seller promises and agrees to convey good, clear, and marketable title to all the property to be sold hereunder, the same to be free and clear of all liens and encumbrances. Full possession of said property will be delivered in the same condition that it is now, reasonable wear and tear expected.


3. All of the terms, representations and warranties shall survive the closing. This Agreement shall bind and inure to the benefit of the Seller and Buyer and their respective heirs, executors, administrators, successors and assigns.

4. If this Agreement shall contain any term or provision which shall be invalid or against public policy or if the application of same is invalid or against public policy, then, the remainder of this Agreement shall not be affected thereby and shall remain in full force and effect.
