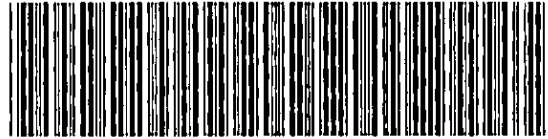

The Corporation has authorized and issued 1,000 shares of stock

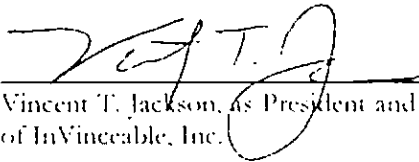

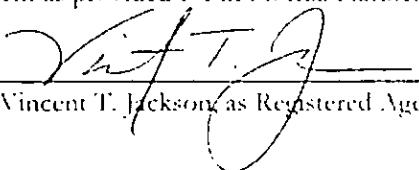
