The business of the corporation shall be managed by the shareholders of the corporation rather than by a board of directors.

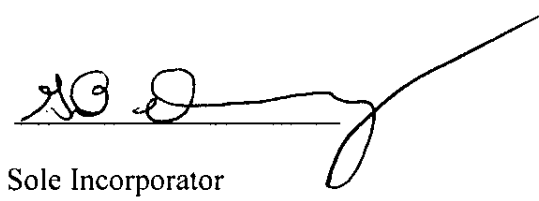

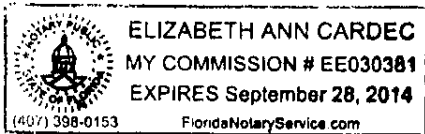

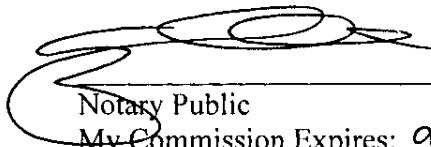
