**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
IMAGINA PRODUCTION SERVICES, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **IMAGINA PRODUCTION SERVICES, INC.** (the "Corporation").
2. The following amendment to the Articles of Incorporation was agreed to and adopted by the incorporator of the Corporation on the 21st day of January, 2014, pursuant to Section 607.1005 of the Act.
