Pursuant to Section 607.1007 of the Business Corporation Act of the State of Florida, the undersigned, being the President of Mediapro US Production Services, Inc. (hereinafter the "Corporation"), a Florida corporation, and desiring to amend and restate its Articles of Incorporation, does hereby certify:

FIRST: Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on January 27, 2014, Document No. P14000008161.

SECOND: Amended and restated articles of incorporation (the "Amended and Restated Articles of Incorporation") were adopted by all of the directors and shareholders of the voting stock of the Corporation pursuant to Sections 607.0821 and 607.0704 of the Florida Business Corporation Act on June 29, 2021. The number of votes cast for the amendment to the Corporation's Articles of Incorporation was sufficient for approval.

THIRD: The text of the Articles of Incorporation is hereby amended and restated as herein set forth in full and shall supersede the original Articles of Incorporation and all amendments to the Articles of Incorporation. The Amended and Restated Articles of Incorporation consolidate all amendments into a single document.


