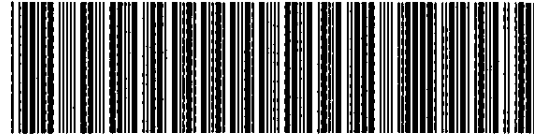

ARTICLE ONE  
NAME

The term of existence of the corporation is perpetual.
