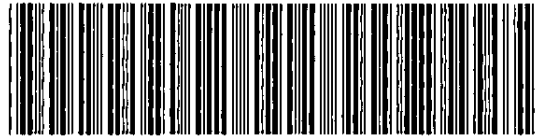

**ARTICLES OF INCORPORATION
OF
TURNBERRY ISLE NORTH ONE CORP.**

ARTICLE I

Name

The name of the corporation is Turnberry Isle North One Corp. (the "Corporation").

ARTICLE II

Principal Office

Incorporator


