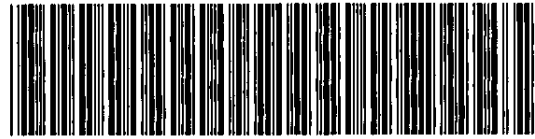

ARTICLES OF INCORPORATION

OF

DUCORE, INC.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of this Corporation is: **DUCORE, INC.**

ARTICLE II - NATURE OF BUSINESS

The Corporation is to provide professional services to the public and to businesses.

ARTICLE III - CAPITAL STOCK


ARTICLE XII - AMENDMENT
