The undersigned, being authorized to execute and file these Articles of Amendment, hereby certifies that:

<u>FIRST</u>: These Articles of Amendment amend the Articles of Incorporation of MOBILETEC HOLDING COMPANY INC. (the "Corporation").

<u>SECOND</u>: The Articles of Incorporation of the Corporation were filed with the Florida Department of State on February 4, 2014, and the Corporation's State of Florida Document Number is P14000010934.

<u>THIRD</u>: Article IV of the Articles of Incorporation of the Corporation previously provided as follows:

"ARTICLE IV

The number of shares the corporation is authorized to issue is: 1,000,000."

The aggregate number of shares of capital stock authorized to be issued by this Corporation shall be 1,000,000 shares of common stock with a par value of \$.001 per share. Each share of said stock shall entitle the holder thereof to one (1) vote at every annual or special meeting of the shareholders of this Corporation. The consideration for the issuance of said shares of capital stock may be paid, in whole or in part, in cash, in promissory notes, in other property (tangible or intangible), in labor or services actually performed for this corporation, in promises to perform services in the future evidenced by a written contract, or in other benefits to this corporation at a fair

valuation to be fixed by the Board of Directors. When issued, all shares of stock shall be fully paid and nonassessable."

<u>FIFTH</u>: I am the incorporator submitting these Articles of Amendment prior to the issuance of any shares of stock and affirm that the facts stated herein are true. I am aware that false information submitted in a document to the Department of State constitutes a third degree felony as provided for in s.817.155, F.S.
