

**ARTICLES OF INCORPORATION
OF
EUPHORIC YOGA AND FITNESS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE 1

Name

The name of the Corporation shall be:

Euphoric Yoga and Fitness, Inc..

ARTICLE 2

Principal Office and Mailing Address

The street address of the principal office of the Corporation shall be: 2239 SoHo Bay Court, Tampa, Florida 33606. The mailing address of the Corporation shall be: P.O. Box 4171, Tampa, Florida 33677.

ARTICLE 3

Capital Stock

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 1,000,000 shares of common stock with a par value of \$.001 per share. Each share of said stock shall entitle the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. The consideration for the issuance of said shares of capital stock may be paid, in whole or in part, in cash, in promissory notes, or in other property (tangible or intangible), in labor or services, actually performed for this corporation, in promises to perform services in the future evidenced by a written contract, or in other benefits to this corporation at a fair valuation to be fixed by the Board of Directors. When issued, all shares of stock shall be fully paid and nonassessable.

ARTICLE 4

Registered Office and Registered Agent

The initial street address of the corporation's registered office shall be: 10246 Estuary Dr., Tampa, Florida, 33647. The initial registered agent for the corporation at that address shall be: Lawrence E. Miccolis. This corporation shall have the right to change the registered agent

and such registered office from time to time, as provided by law.

ARTICLE 5

Board of Directors

The Board of Directors of this corporation shall consist of a number of directors to be fixed from time to time by stockholders or the bylaws. The business and affairs of this corporation shall be managed by the Board of Directors, which may exercise all such powers of this corporation and do all such lawful acts and things as are not by law directed or required to be exercised or done only by stockholders.

Bylaws




