## ARTICLES OF INCORPORATION OF LC VENTURES OF INDIAN RIVER, INC

SCALE OF THE SEASON OF THE SEA

The undersigned hereby associates for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the state providing for the formation, liability, rights, privileges and immunities of a corporation for profit, and does hereby make, subscribe, acknowledge and file these Articles of Incorporation.

#### **ARTICLE I**
